October 4, 2016 Fire Commission Meeting Minutes

1. Approval of Agenda-Call to order 7:05 pm.
 - **M/S Marinoff/Curran to approve adjusted agenda. All in favor.**
2. Public Comment on Non agenda items.
 - Linda Barnello made a brief statement commending the firefighters for their commitment to the community and all their hard work during the summer months especially as the department struggled with some staffing issues. Chief echoed her words. Linda then gave a very generous donation of \$2500 dollars to the Marinwood Firefighter's Association to be used for the purchase of new air monitoring gas detector. The gas detector had just been purchased and Acting Captain gave a brief presentation on on how it works and it's importance. The Commission thanked her for her generosity and thought the Chief some write something for NextDoor and notify the IJ for a possible story. Both were done.
3. Approval of September 2016 Minutes
 - **M/S Curran/Elsbree to approve the September Commission Minutes. All in favor.**
4. September Activity Schedule and Response Report.
 - The September Activity Schedule was reviewed. Chief commented that September was a busy month in terms of emergency calls, preparing for wildland season, training probationary employees, and getting two department members Acting Engineer Certified. Commissioner Schwartz asked about the meeting Eric and I had with Rocking H Ranch developers. Eric gave a brief description including the developers are hoping to annex to Marinwood and asked the Chief to provide some fire department requirements on the development. Irv provided some information from Ray Morwitz and Scott Alber that had been submitted on a previous project.
 - The September Response Report was reviewed. Commissioner Marinoff asked if the three calls in CSA 13 at the beginning of the month were all at the same address. Chief said they were not. Commisisoner Curran had a question about a "structure fire" response that had the engine responding and then available all within 1 minute. Chief commented that it was probably a structure fire response that they were cancelled on right as they left.
5. Bill of Sale and Release of Liability
 - The Commission reviewed the Release of Liability and the Bill of Sale to be used for the sale of the Reserve Type 1. Chief commented that both had been reviewed by counsel. Since some surplus equipment is going with the sale of the engine it was recommended that the list of equipment be attached and included in the Release of Liability and that Section IV of the Bill of Sale discussing the condition of the engine be removed. Both changes have been made in each document. **M/S Elsbree/Curran to recommend the sale of the engine for the stated price and that the Board approve both the Release of Liability Form and the Bill of Sale with the noted changes and that the \$18,000 be**

earmarked for the purchase of a new Utility Truck for the fire department in future years. All in favor.

6. Chief Report and Grant Update

- Chief gave a report on the Assistance to Firefighter Grant. All SCBA's and related equipment has been ordered and funds requested from Department of Homeland Security to pay for the equipment. The equipment and the requested funds should both arrive within four to five weeks.
- Chief gave an update on the Disaster Preparedness Trailer. Work has begun on the outfitting the inside of the trailer with necessary disaster supplies. Four volunteer firefighters are assisting the Chief with the project.

7. 2016 California Fire Code Adoption

- Chief gave a brief update on why the District has to go through this process. It's something done every three years. He stated that the District adopts exactly the same code as the County. The Marin County Fire Prevention Officer's have been very helpful with this process. Commissioner Schwartz noted a few errors in the Summary of Resolution Document that have been changed. Additionally, Commissioner Stilson noted a few typos in the Resolution. **M/S Curran/Marinoff Recommending the adoption of Resolution 2016-08. All in favor.**

8. Succession Planning for the Implementation of Paramedics

- Chief Roach gave a brief update on Jeff Smith completing Probation and passing his Acting Engineer Certification. Probationary Firefighter Sean Day should complete Probation and pass his Acting Engineer certification by early November. Chief also spoke about the current paramedic recruitment going on. Applications are being taken until this Friday, October 7 with interviews later this month or into November. The next new hire academy starts December 19.
- Next Meeting scheduled for December. I will be on vacation the first week of November.

Prior to the October Fire Commission Meeting there was a scheduled walk through of the firehouse to note it's condition and make notes of needed improvements. Following are the notes from that walk through-

- *Front entry way has some cracked tiles leading to the Captains Office. It is not a trip hazard.
- *The Captain's Office needs new carpet. Or possibly replace the carpet with something more durable and longer lasting.
- *The kitchen is 22 years old and needs cabinet refacing and new countertops and flooring. Possibly a new stove and dishwasher also.
- *The bunk room needs new carpet. Or possibly replacing the carpet with something more durable and longer lasting.
- *Bathrooms could use some tile repair, installation of low flow toilets, sheet rock repair near the showers, and new shower pans.
- *The back shed needs to be replaced. Possibly with a much larger tough shed product for additional storage space.
- *New turnout lockers for both the paid and volunteer staff, with possible relocation of paid lockers to back storage room.
- *It was discussed that the firehouse is not currently set up to accommodate a female firefighter and the required privacy that comes with that.

5 New volunteers were hired in November bringing the total to 20. They begin the last Wednesday of the month.

EMERGENCY CALLS

The department responded to 200 emergency calls in October and November. Most were medical in nature. The department did respond to three vehicle fires, one debris fire, and one small grass fire in Marinwood, two vehicle fires in San Rafael, and two structure fires in San Rafael.

COMMUNITY SERVICE/PREVENTION/ASSOCIATION MEETINGS

- I completed five final inspections of new solar systems in Marinwood during October and November.
- Two final residential sprinkler system inspections in Marinwood in November.
- One Fire Commission Meeting was held in October.
- I, along with help from four volunteers, continue to work on the disaster preparedness trailer in October and November.
- Two fundraising rides to school were completed in October.
- I attended the MERA Executive Board and Governing Board meeting in October.
- The SCBA Grant has been managed, bids received, equipment ordered, and funds from the grant requested. We are still awaiting word on approval of the request for funds and delivery of the SCBA's. The department should hear back from both by mid-November.
- I met with the Sheriff Office Training Coordinator to see the room where the Captain's written test will be administered.
- I met with Kelby Jones of LVHA to help getting vegetation management work done on a few homeowners property in their area. We walked all the homes in the boundary between the homes and open space. All but three have complied with vegetation management.
- The department assisted a homeowner in Mont Marin with refilling their swimming pool.
- I continued working with the Lions Club on CERT related issues, including mapping and radio protocol.
- A cert meeting was held at the firehouse in October.
- I started writing a new Assistance to Firefighters Grant for a new Utility Vehicle.
- Marinwood hosted a San Rafael Fire Commission Meeting in October.
- I provided construction and development feedback to the architect and general contractor for the Rocking H Ranch four homes development off of Lucas Valley Road in October.
- The Great California Shakeout was help in October. Residents were encouraged to review their earthquake preparedness during the month.
- The department engine with personnel went to the St. Vincent's pumpkin patch twice during the October to show the engine.
- The station was a drop off point during a weekend day in October for the prescription drug take back day.
- The Rob Paoli Memorial Basketball Tournament was held in November.
- Marinwood CERT sponsored a Get Ready Class in November.
- Marinwood CERT sponsored a First Aid for Disaster Response in November.

TRAINING

- Six minutes of Safety training was reviewed daily by on duty staff.

- Department Personnel continued with the Target Safety Training Program during October.
- All three shifts went through multi company drill in October. HazMat was the topic.
- Jeff Smith completed his one year probationary training in September and is now qualified as an Acting Engineer.
- Four Volunteer drills were held in October. Topics included new volunteer orientation, ladders and hoselines aloft, and HazMat.
- Keith Larson continued with his probationary training and studying for his 6 month evaluation.
- Sean Day continued with his Acting Engineer training. Sean Day will be tested on November 17 and 18.
- The two Captain's candidates and I and the Union Representative held a meeting regarding the Captains testing process in October.
- Four new Volunteer Firefighters were hired in November and began their orientation.
- I held Chief interviews for new Firefighter Paramedic hires.

MAINTENANCE

- All 4 department vehicles underwent a comprehensive monthly check during October.
- The reserve engine was sold and taken away by Long Valley Volunteer FD in October. A training was given to their personnel who picked it up. I also have had multiple calls from their chief with questions.
- All gas-powered equipment was checked weekly during the month.
- All vehicle batteries were serviced and charged on a weekly basis during the month.
- The new engine went to Sacramento in late October for some warranty work. A separate sheet is included in the packet with the work that is being done
- New exercise equipment was ordered and placed in service during October.
- An SDRMA Inspection was done in November.

New Website Update

Included in the email distributing the Commission Packet was a link to the Districts new website include a Fire Department link. Izabela will give a presentation at the Commission meeting. Feel free to go to the site and provide feedback or ideas. It is a work in progress and once live will continue to be a site improvements and additions can easily be made to.

Assistance To Firefighter Grant Update

For the 2016 AFG Grant the department took delivery of 14 new Scott SCBA's, Rapid Intervention Pack, and Personal Device Locator and placed all in service. The bill was paid. \$115,000 total. Grant paid \$109,000, District contribution \$6,000. I have a number of reports and upkeep to managing the grant over the next year.

For the 2017 AFG Grant I submitted for a new Utility Light Rescue Pick Up Truck. I wrote for \$39,000 and said the District can contribute \$18,000. Won't know the result until at least middle of 2017.

Community Service Grant Update

I continue to work with four volunteers to equip the trailer with all necessary supplies. Hope to have it completed by the end of the year.

New Engine Warranty work

The new engine has been at Cummings in Sacramento having some warranty work done. Included in the packet is a list of the work. Should be back by time of the Commission meeting.

Fire Commission Vice Chair Appointment and Commissioner Reappointment and Commission Vacancy

Irv Schwartz has been appointed to the Board of Directors so there is an opening for a Commission Vice Chair. I believe Dan Curran has expressed an interest. Also, Dan Curran, Tom Elsbree, and Russ Albano terms are expiring at the end of December. I believe all are interested in being reappointed. Lastly, there is a vacancy on the Commission with Irv's promotion. One person has expressed interest, hopefully he will come to the Commission meeting.

Captain's Testing Process

Two candidates applied for the Fire Captain's promotional process. Both took the written exam and will be moving on to the Assessment Center which will take place on Dec 14 and 15. I can provide additional details of what is included in the Assessment Center Evaluation at the meeting if the Commission would like.

Succession Planning for implementation of Paramedic Positions

The department currently has one paramedics on a 24 hour shift. He is current and licensed in Marin County as a Paramedic. He attends on going paramedic trainings and CQI study sessions with San Rafael FD.

Firefighter Paramedic Oral Boards and Chief Oral Boards of the top five candidates were completed in November. I have a list of some very qualified Firefighter Paramedics.

The Joint new hire academy is now scheduled to begin January 9.

The department currently has one opening. I am going to fill that position for sure with a firefighter paramedic from the top three.

The department currently has two long term workers comp injuries. I do not have a timeline for either's return or if it will lead to eventual separation from the department. Currently both are rehabilitating going through physical therapy and contemplating possible surgical intervention. Both have the option of returning when they are healthy and cleared by the physician.

The question to contemplate, should the department offer a position to a second firefighter paramedic candidate and send him or her through the new hire academy. Below are the list of pro's and con's-

Pro's-

- *Get the department staffing back up to ten fulltime personnel.
- *Reduce overtime.
- *Provide for shift and staffing continuity.
- *Reduce extended hours for all staff members.
- *Allow department to participate in strike team assignments again.
- *Have three paramedics in the department.
- *The timing with a joint new hire academy works perfectly. Not sure when the next academy would occur which could delay a new hire when the department needs one.

Con's-

- *Currently Board is in labor negotiations with union. The overhire will cause an increase in fulltime wage costs, as the department will employ 11 fulltime employees as opposed to 10. Would that extra money be better used towards a raise for current employees?
- *If both injured employees return to work the overhire staff member would be released until such a time as another full time position opened up or long term injury occurred.

Options-

- 1. Do not hire a second firefighter paramedic and wait for the two workers comp cases sort themselves out into either return to work or IDR status.**
- 2. Hire a second fulltime firefighter paramedic, send them through the academy and when completed put them on staff with the understanding that should both workers comp injuries return to work they will be released from work until there is another opening or another long term injury occurs.**
- 3. Hire a second firefighter paramedic as a temporary employee, send them through the academy and when completed put them on staff with the understanding that should both workers comp injuries return to work they will be released from work until there is another opening or another long term injury occurs. The temporary employee status will allow the District to both get a new employee working and trained and have some savings by not having to pay for the benefits and retirement initially of the employee. We could employ the employee for up to 1000 hours this way, which would last about 4 months. At the conclusion of 1000 hours the department may know more about the status of the workers comp cases and could decide then to either release the employee or hire him or her full time.**

I recommend proceeding with option 3. We will discuss this at the Commission meeting and I will be looking for a recommendation from the Commission on this matter.
