Re: Proposed Bylaws Amendment

Commissioners,

In accordance with the P&R Commission Bylaws (http://www.marinwood.org/ParkRecCommission), the Commission has traditionally engaged in annual physical visits to identified facilities/areas as a component of their regular meetings during the summer months (May – September). As discussed at the June 2019 P&R Commission meeting, the Commission desires to expand the available options by which it can learn about specific District facilities and areas in lieu of physical visits when appropriate and decided upon by the Commission.

Such an action by the Commission would require a recommendation to amend the current bylaws, subject to formal approval of the Board of Directors. The applicable section of the current bylaws as well as a proposed amendment are below.

The current Park & Recreation Commission Bylaws state:

ARTICLE III – COMMISSIONERS' RESPONSIBILITIES

7. Inspect Park and Recreation Department facilities annually during summer months and develop a list of recommended improvements.

Proposed amendment:

ARTICLE III – COMMISSIONERS' RESPONSIBILITIES

7. Conduct physical inspections of or receive staff reports regarding Park and Recreation Department facilities as deemed appropriate by the Commission; Maintain a list of recommended improvements as appropriate.

As you are aware, staff time and resources are severely impacted during busy summer months. As such and primarily due to additional staff time required for the potential creation of reports, staff requests removing a specific timeframe by which this activity will occur and further requests the aforementioned staff reports not be requested during summer months.

Staff recommends approving the proposed amendment as presented for final approval by the Board of Directors.
