Re: Fire Department Update

Marin Wildfire Prevention Authority-Vegetation Management

Reimbursement checks have been sent to the agencies for their local and defensible space expenditures. The revenues received thus far were slightly higher than expected (1-2%). The recruitment for the Emergency Planning and Program Manager is anticipated to start in February. A Draft Request For Proposal for an environmental services expert is under way and it is anticipated that the individual/firm selected will be directly available to contribute to the Fiscal Year 21-22 workplan and can support each agency's effort for evaluating their projects to ensure environmental considerations and best practices.

Zonehaven (who provides an evacuation management platform) has been contracted and they are scheduled to start the bulk of their work in February with an estimated completion date in May 2021. Their platform will include participation from fire agencies, law enforcement agencies, Marin Office of Emergency Services, Transportation Authority of Marin, California Highway Patrol, California Transportation Authority (Cal Trans), and Department of Public Works. This tool can generate rapid simulations and will assist with real time situational awareness for first responders and community members during emergencies and/or training.

The 2020 Marin Community Wildfire Protection Plan (CWPP) has been released and contains a substantial amount of very informative and revealing information about your community. Guidelines/COVID-19:

The most recent surge is decreasing in Marin & the Bay Area with drops in most indicators following the recent pattern of positive cases, hospitalizations & ICU, and then deaths. On January 25, 2021, the California Department of Public Health (CDPH) announced that the stay-at-home order has been lifted statewide effective immediately. This allows restaurants (outdoor dining), personal services, and various other consumer operations to reopen. Businesses allowed to serve customers indoors now include: Hair salons and barbershops; personal services (nail salons, estheticians, massage studios, tattoo parlors, piercing shops); limited services (carwashes, dry cleaners, electricians, handypersons/general contractors, heating and air conditioning services,

landscapers, laundromats, pet groomers, plumbing services, janitorial/cleaning services); hotels, motels and short-term lodging; retail stores and malls, at 25% capacity; and libraries, at 25% capacity. Among the operations allowed to serve customers outdoors: Restaurants (outdoor dining); places of worship; gyms and fitness/dance/yoga studios; family entertainment centers; day camps; wineries; card rooms; campgrounds and playgrounds; youth and adult recreational athletics programs.

Marin & most of the state are now back in the Purple level – this is the tier in which widespread infections are still a serious and present threat.

Point of Dispensing (POD) operations are continuing in the county and due to low/limited vaccine availability from the state, they are not operating at full capability. The Marin Center Super POD operations have been cut back to five days a week from a planned seven. The POD at the Marin Civic Center in San Rafael has been operational since Thursday January 14, 2021 and plans are being built for a Southern Marin POD which will be run with Marin Health. There are plans of a potential drive through POD and plans are being crafted with pharmacies and One Medical.

As of January 26, 2021, the groups currently eligible for vaccine include:


- Phase 1A groups (e.g., Healthcare workers and residents of residential care facilities for the elderly)
- Marin County residents age 75 & older


The United States has had 25, 273, 534 cases to date with 420, 963 deaths. The State of California has 3,191, 651 persons infected by COVID with 37, 386 deaths. The Bay Area has 357, 404 cases of COVID and 3, 854 deaths. Marin County has had 8,879 cases reported with 137 deaths to-date.

Vaccinations:

As of January 25, 2021, approximately 23,953 persons in Marin have received vaccinations. 20, 262 received their first vaccination and approximately 3,691 received both doses.

Overturned Vehicles

On January 24, 2021, San Rafael and Marinwood firefighters, along with CHP and the Marin County Sheriff's Office, responded to a couple of separate vehicle accidents on Northbound Highway 101. Marinwood Engine 58 treated the occupants for minor injuries and returned to service.

Volunteer Program

Captain John Papanikolaou and Chief White are scheduled to meet on February 2, 2021 about the Marinwood Volunteer Firefighter program. It is anticipated that the program can be gradually resurrected since both paid and volunteer members have completed COVID-19 vaccinations. As the Marin County Training Consortium resumes its operations, we anticipate refresher training to be one of the key priorities. Chief White will provide updates at the Commission meeting.

Marinwood Fire Department Statistics: January 2021

The Marinwood Fire Department has responded to 68 emergency calls in January 2021 through January 26; of these, 10 calls were cancelled en route. More than half of the calls were medical incidents, including one call in which COVID-19 was confirmed. The department responded to one structure fire and one chimney fire in Marinwood.
