Re: Expiring Commissioner Terms and Reappointment Process

Commissioners,

During the meeting conducted on February 6, 2024, the Fire Commission briefly discussed the topic of identifying potential strategic initiatives and/or projects the Commission could focus on that would provide benefit to the Fire Department, the CSD and the community as a whole. It was decided an effective process for the initial identification of such initiatives/projects would be through the formation of a working group that would then bring potential ideas back to the entire Commission for further discussion.

The working group should consist of no more than two commissioners (less than a quorum of the Commission), the District Manager and the Fire Chief. Once formed, the group will identify meeting dates based on their collective availability. Further, the group may invite on-duty fire personnel to participate in working group meetings as well as to participate in discussions taking place during applicable fire commission meetings.

<u>Staff Recommendation:</u> Approve the formation of the working group as described above and appoint no more than two commissioners to participate in the group.
