As a component of the Commission's discussion regarding the Marinwood Park Play Structure Replacement Initiative, please see the included initial draft of a forthcoming community survey. Marinwood Playground Community Survey

The play structures within the Marinwood Park playground are starting to approach the end of their useful life and it is getting increasingly difficult to find replacement parts to repair the equipment when needed. As such, Marinwood CSD has secured matching grant funds designated for the replacement of these highly utilized play structures.

Parks and Recreation Report May 2021 Submitted by: Luke Fretwell, Recreation Director

RECREATION

This past month was marked by the start of Recreation Swim reservations and private swim lessons at the pool, filling the remaining summer camp openings from the waitlist, opening up picnic rentals in the park, part-time staff trainings, and much preparation for the summer.

Summer Camp Enrollment

This past week staff finally finished filling the more than 500 open camp spots from the waiting list. After getting through the waitlists a small handful of openings remain but are filling up quickly.

Pool

On May 15th and 16th we had our first Recreation Swim reservations of the season. We are currently offering 2 different 2-hour Rec Swim timeslots on weekend afternoons and allowing up to 10 small groups per timeslot. In keeping with COVID guidance, each group has their own picnic area with picnic table, umbrella, and lounge chairs. The first weekend went smoothly. Reservations continue to come in and we are at or near capacity for most weekends this spring.

This past weekend we also began offering private and semi-private swim lessons on the weekends. Our first weekend of lessons went well with everyone easily adapting to the COVID protocols in place. We have begun adding lesson opportunities to accommodate the high demand we have seen this season.

Picnic Rentals

On May 3rd we began accepting reservations for our 2 group picnic areas in the park and reservations have been pouring in.

Summer Preparation

In addition to all the scheduling, planning, and ordering supplies for this summer, John Paul and Robyn have begun running trainings and orientations for our part-time spring and summer staff members. With a summer staff of over 200 high school and college employees, this is no small task. All our lifeguards undergo rigorous rescue, first aid, and CPR training (in addition to their lifeguard certification), and all our camp counselors and pool attendants get trained in CPR/AED and First Aid each summer. Providing a safe environment for our participants is always our top priority in all our programs.

PARKS & BUILDING MAINTENANCE

This past month the Parks Staff continued landscaping work on the firemen's hill, began fortifying the turf ahead of the heavy summer foot traffic, cleaned up the landscaping at the Mini Park and Creekside Park, repaired two irrigation leaks discovered on the field near the tennis courts, and began addressing damage done to the equipment at the mini park playground.

Firemen's Hill Landscaping Update

This past month staff finished completely rebuilding the 200 ft. retaining wall along the walking path that had become rotted and broken. Defunct and outdated irrigation lines were replaced and rerouted to be used for future plantings. Weeds, debris, and rock were removed, and weed barrier and fresh woodchips were spread over the entirety of the area. Staff will be resurfacing the walking path and pruning the trees and plants in the coming days and weeks. Additional plantings, decorative stones, and new signage will be added in the coming months. Staff continue to work on this project as time allows during limited windows between the numerous other maintenance duties and the inevitable unplanned repairs that pop up. I am grateful to Estevan and Marco for their continued hard work on this exceptionally large project.

Turf

The staff has begun aerating, seeding, and fertilizing the turf ahead of the summer. The goal is always to get things as fortified and robust as possible before the heavy foot traffic of summer camps and other heavy summer park use ensues.

Damage at Mini Park

Over the weekend of May 15th the Mini Park playground was vandalized leaving two of the platforms badly damaged and rendered unsafe. Staff immediately blocked off the unsafe areas with plywood and signage and we are looking into acquiring replacement parts.

Upcoming projects include more work on the firemen's hill landscaping, installing shade sails around the community center to provide shade for the summer camps, and painting at the pool.

Recruitment efforts continue to fill our vacant maintenance worker position and I hope I will have news by next month.

Daily/Weekly Duties:

- Clean and restock Community Center building and park bathroom
- Blow/rake leaves around community center
- Empty garbage and dog waste receptacles in 3 parks and at trailhead
- Mow lawns in 3 parks and pool
- Irrigation inspection in 3 parks
- Check 3 playgrounds for graffiti and hazards
- Check and adjust pool chemistry/equipment
