Re: P&R Commission Bylaws Amendment: Adjusting Regular Meeting Schedule to Bi-Monthly

# Commissioners,

At the August 23, 2022 Park & Recreation (P&R) Commission meeting the Commission briefly spoke about the possibility of transitioning from monthly regular meetings to bi-monthly regular meetings.

Such a change in the regular meeting schedule would require a formal amendment to the P&R Commission Bylaws, subject to the final approval of the Marinwood CSD Board of Directors. It should be noted, such an amendment to the Bylaws would not prevent the P&R Commission from conducting a Special Meeting during off months should circumstances or other conditions warrant the need for an additional meeting(s).

Should the P&R Commission decide such an amendment be approved for recommendation to the Board of Directors, staff suggests the Commission recommend regular meetings be conducted every odd numbered month. The Commission does not typically conduct a meeting in December during the holiday season. Conducting bi-monthly meetings every odd numbered month would alleviate this conflict.

# **ARTICLE V – MEETINGS**

# A. TIME AND PLACE

The Commission shall hold regular meetings every fourth Tuesday of the month at 7:00 PM in the small classroom at the Marinwood Community Center, unless otherwise necessary. Public notice of all meetings shall be given in accordance with the provisions of The Ralph M. Brown Act. The meetings shall be open to the public.

# **B. SPECIAL MEETINGS**

Special meetings may be called by the Chairperson, by three members of the Commission, or by the Board. Public notice of all meetings shall be given in accordance with the provisions of the Ralph M. Brown Act. The meetings shall be open to the public.

The following bylaws amendment is proposed to accomplish transitioning from monthly regular meetings to bi-monthly regular meetings (amendments marked in red):

# **ARTICLE V – MEETINGS**

# A. TIME AND PLACE

The Commission shall hold regular meetings every the first Tuesday of the every odd numbered month (January, March, May, July, September, November) at 7:00 PM in the small classroom at the Marinwood Community Center, unless otherwise necessary. Public notice of all meetings shall be given in accordance with the provisions of The Ralph M. Brown Act. The meetings shall be open to the public.

# **B. SPECIAL MEETINGS**

Special meetings may be called by the Chairperson, by three members of the Commission, or by the Board. Public notice of all meetings shall be given in accordance with the provisions of the Ralph M. Brown Act. The meetings shall be open to the public.

As the final authority for all Commission bylaws amendments rests with the Board of Directors, should the Commission choose to recommend the above bylaws amendment this topic will be placed on the agenda of the next Board of Directors meeting scheduled for October 11, 2022. Should the Board of Directors subsequently approve the amendment, it would become effective immediately thereafter and the next P&R Commission regular meeting would be conducted on November 22, 2022, accordingly.

Re: Miller Creek Trail Initiative: Potential Planning & Research Process

# Commissioners,

The purpose of this agenda item is to provide context on the current status of the Miller Creek Trail initiative and to discuss the potential planning and research process involved with the possible implementation of this initiative.

It is the perspective of staff that this initiative is still very much in the potential project exploration phase. Below are the initial exploratory planning steps either completed thus far, currently underway or yet to begin (the primary focus of discussion for this meeting will be the item 3):

- 1. Identify the project scope and receive a qualified estimate for current construction cost *(completed)*.
- 2. Establish a formal agreement with the developer of the proposed senior living center regarding their financial contribution obligation as stated in the applicable Oakview Subdivision Improvement Agreement formed in 2006 (currently underway, near completion).
- 3. Identify and receive cost estimates on the remaining planning research and other cost items needed, potentially including but not limited to required biological studies, public outreach, potential permitting fees, etc. (yet to begin).

Moving forward, upon completion of steps 2 and 3 above this item will be placed on a public meeting agenda of the Board of Directors to present anticipated project cost and applicable resource allocation impact to the District. If the Board of Directors votes to commit the funding and resources to continue this initiative, staff will initiate the identified research (timing dependent) and other planning processes identified in step 3 above.

Dear Park and Recreation Commission,

I requested an agenda item be put on your agenda for consideration and feedback at the meeting on Tuesday. Unfortunately I may not be able to attend the meeting, so I'd like to introduce the item and give it some context for your consideration.

I'm asking the commission to consider and make a recommendation on adding picnic style tables to a few places in our Open Space. I'm envisioning somewhere between 5 and 10 picnic tables that we place at some identified locations that hikers and bikers might commonly stop in the Open Space to enjoy the view. It's simply a way to add to the Open Space experience. As a hiker, if I ever want to stop and enjoy the view, have lunch or whatever, I have to sit on the ground in almost all of the hills in the Marinwood Open Space. That seems like an easy fix. We could identify a few key lookouts and put a table there. Most other places I hike have tables and other amenities, so this seems to be a common practice. I think some people might be worried about trash, but people who are hiking/biking our hills are "pack it in and pack it out" kind of people. Yeah, the tables may get defaced, but if we were worried about that we would never put any amenities in the park and I don't think we have that philosophy. So that's where I'm coming from on this one. I see it as an easy addition to create an even more spectacular Open Space experience.

# **RECREATION ACTIVITY REPORT**

# Marinwood Preschool

Marinwood's preschool program opened for the school year on Tuesday, September 6<sup>th</sup>. We are currently offering two classes—one for 3-year-olds and one for 4-year-olds. We are excited to have new teacher Jolene in the threes class this year. The first few weeks have gone well.

# <u>Pool</u>

The pool remains open through October 7<sup>th</sup>. We are currently offering adult lap swim, recreation swim, tot pool hours, private swim lessons, pool party rentals, and water polo. With the last of our college age staff leaving this week, staffing will be a challenge for the remainder of the season. We are, however, working on getting a few extra lifeguards trained to help cover some of the midday hours and are looking to be in good shape for rest of the season.

#### Halloween Harvest Festival

Our annual Halloween event will take place Friday, October 14<sup>th</sup> from 5-6:30pm. This year's event will feature carnival games, arts & crafts, a mini pumpkin patch, a costume photo station, and bounce houses. Following the success of last year's event, we will plan to run the festival outdoors, weather permitting. The Halloween Harvest Festival is historically our most well-attended family event.

# Fall Art Show

Our annual Fall Art Show will take place on Saturday, October 22<sup>nd</sup> from 3:00pm-7:00pm in the community center. The theme of this show is "Form & Color" and will feature works from some of Marin County's finest artist.

Our semi-annual art shows have developed a positive reputation in Marin for the high quality of the artwork as well as the execution of the show. We are grateful to be able to work with Susan Press who not only has a keen eye for good art, but also has built positive and lasting relationships with the local art community, allowing us to put on a show that caters both to the art community as well as the general public.

# Other Programs

Programs being offered this fall include adult and youth tennis, Irish Dance, Capoeira, Photography, Pilates, Zumba, LEGO engineering, art for kids, All Sorts of Sports, youth soccer, music for tots, and more. Staff continues to work on adding additional adult programming after some of our longstanding instructors have decided to retire after COVID put their classes on hold for so long.

#### PARKS MAINTENANCE ACTIVITY REPORT

# Turf

This past month the staff has been working diligently to rehabilitate the turf after the heavy summer use. These efforts have included extensive aerating, fertilizing, and seeding, as well as making adjustments to irrigation for better coverage and efficiency. There is still work to be done but the turf is looking much improved.

# **Drinking Fountains**

A broken water line at the firemen's picnic area was repaired earlier this month and the water fountain is back in working order.

We are currently looking into replacements for some of the older drinking fountains in the park that have become dilapidated and challenging to maintain.

# Fence Repair

This past month repairs were made to a broken stretch of split rail fencing in the firemen's picnic area. Shortly after, staff also erected a new split rail fence around the catchment basin adjacent to the parks maintenance facility.

# Watering

With the current heat wave threatening some of our plantings throughout the neighborhood (primarily the areas around the two wooden Marinwood signs), staff has been proactively and frequently watering to keep everything alive and healthy. When watering offsite, we use a water trailer filled with reclaimed water.

# **Upcoming Projects:**

- -Repairs to fencing in the parking lot
- -Repairs to the pool showers and sinks
- -New plantings along the Firemen's Hill and at Creekside Park
- -Tree pruning throughout the park

# Daily/Weekly Duties:

- Clean and restock Community Center building and park bathroom
- Blow/rake leaves around community center
- Empty garbage and dog waste receptacles in 3 parks and at trailhead
- Mow lawns in 3 parks and pool
- Irrigation inspection in 3 parks
- Check 3 playgrounds for graffiti and hazards
- Check and adjust pool chemistry/equipment
